## Lawful basis for processing your data

Some information may be shared with our Accountants for the purpose of Business accounting.

We will not sell or distribute your personal data to third parties.

We will share personal data with law enforcement or other authorities if required by applicable law.

### How long data is kept

We will only retain your data so long as it is necessary for the purpose for which it was collected. Data will be securely destroyed when no longer required. We will periodically assess the data held and only that which remains current will be retained.

If at any point you believe the data we hold is inaccurate or needs to be updated you can request to see this information and have it corrected or deleted.

### Your rights

You have the right to request a copy of the personal data that we hold about you and the right to have this data updated if necessary. We aim to keep your personal data as accurate as possible. You also have the right to request that your personal data is deleted if it is no longer necessary for us to hold it for the purpose for which it was collected.
